As Senior General Manager at thyssenkrupp Veerhaven, he was most recently responsible for all operational activities such as push barging activities and maritime shipping agencies. This extensive sector expertise, combined with a deep understanding of the operating processes and the commercial requirements, makes him the ideal person to fill this position to ensure the ongoing development of the strategically significant business site in Rotterdam.

As part of the so-called ARAG range, which comprises the ports in Antwerp, Amsterdam and Ghent as well as Rotterdam, this business site plays a key role for European internal and foreign trade. "By appointing Jos Davidse, we're making a clear statement about our ambitions in Rotterdam. Sustainable and innovative transport solutions, which are becoming necessary as a result of the energy transition and the new groups of goods associated with

it, will be a particular focal point for the future development of business. Push barging will also play a crucial role in this process," says Steffen Bauer, the CEO of HGK Shipping.
